**TOWN OF KERROBERT**

**BYLAW No. 1075-21**

**A BYLAW OF THE TOWN OF KERROBERT TO AMEND BYLAW No. 994-14 KNOWN AS THE OFFICIAL COMMUNITY PLAN**

The Council of the Town of Kerrobert, in the Province of Saskatchewan, enacts this bylaw to amend Bylaw No. 994-14 as follows:

1. The **TOWN OF KERROBERT FUTURE LAND USE MAP**, which is attached to and forms part of the Official Community Plan as *Appendix "A"*, is amended by repealing the land use designation scheme of the RM of Mariposa No. 350, and it replacing it with a new land use designation scheme as follows:
  - a. By designating as **Green Space**, all of: Parcel A, Plan 88S05906 Ext. 0; and the area within NW 18-34-22-W3M Ext. 42 including the Kerrobert Reservoir bounded by the approximate location of the nature trail lying southwest of the reservoir, as shown generally within the bold-dashed line on the map attached to and forming part of this bylaw as Schedule "A".
  - b. By designating as **Industrial**, all of: Parcel A, Plan FK4093 Ext. 0; Parcel B, Plan FK4093 Ext. 0; Parcel A, Plan 101610492 Ext. 36; Parcel C, Plan 101610469 Ext. 35; Parcel A, Plan FB3040 Ext. 0; and, Parcel B, Plan 101610458 Ext. 6;  
  
and, that portion of NW 18-34-22-W3M Ext. 41, lying south of the southern boundary of Parcel B, Plan 101610458 Ext. 6 as hypothetically projected to the east to the right-of-way of Highway 51, as shown within the bold-dashed line on the map attached to and forming part of this bylaw as Schedule "B".
  - c. The balance of the lands within W ½ 18-34-22-W3M are not given a specific land use designation.

**This bylaw shall become effective upon approval by the Minister of Government Relations.**

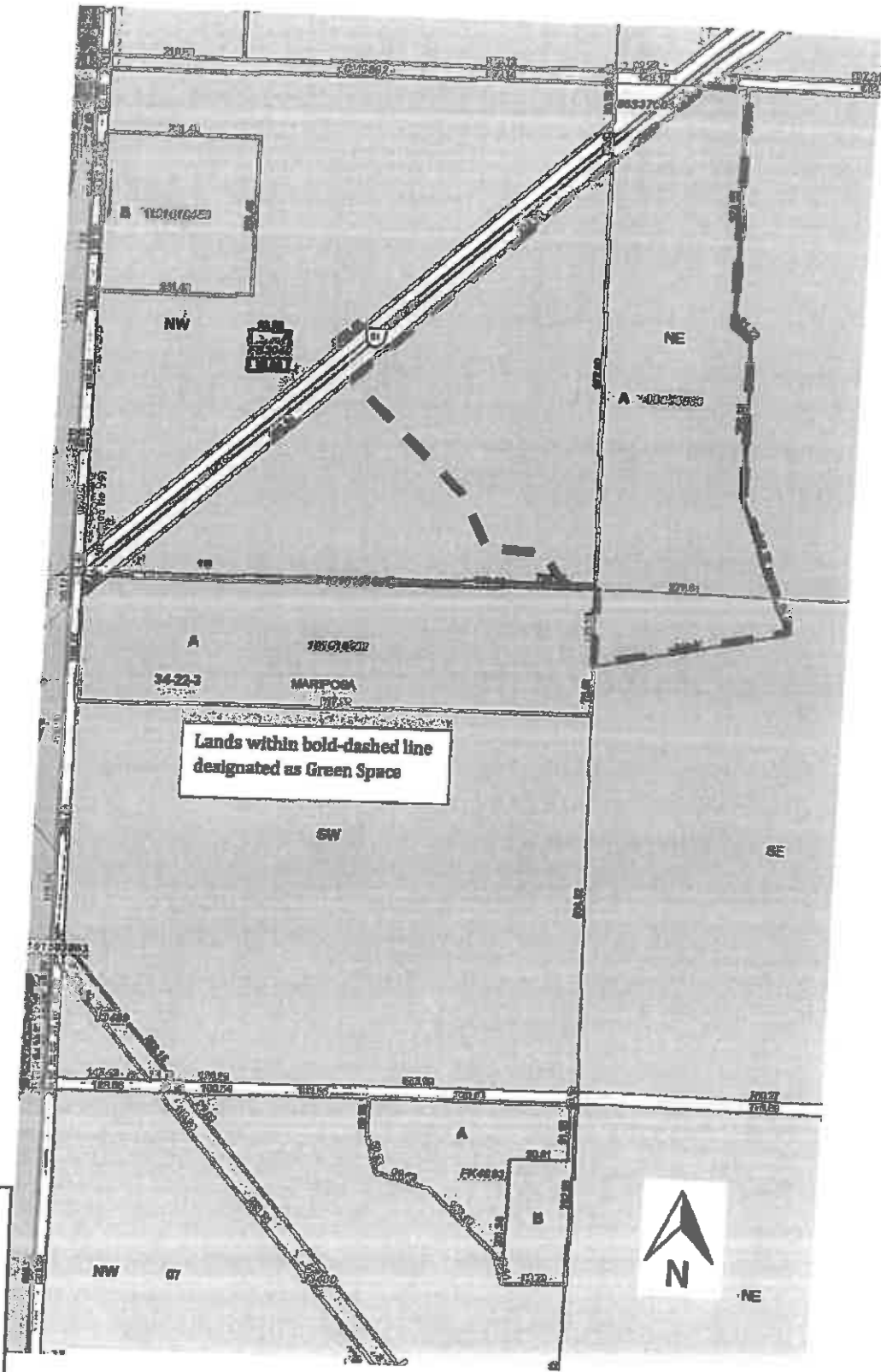

Schedule "A" to Bylaw No. 1075-21

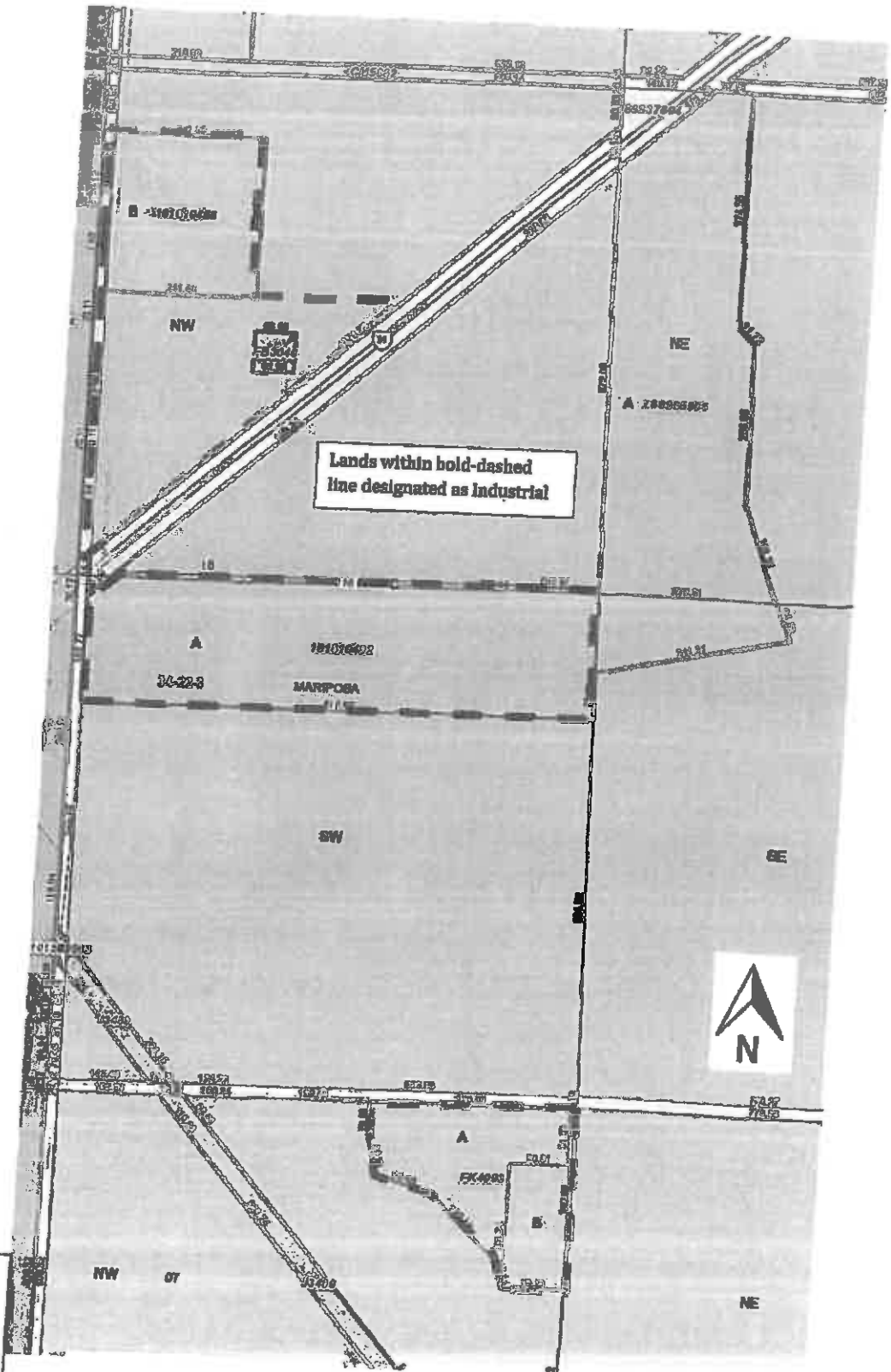


Lands within bold-dashed line
