

PROPERTY SETBACKS - RESIDENTIAL R1 ZONING DISTRICT


Property Setbacks are measurements which determine where you can place your home and any accessory buildings on the property you own so that all neighbours can live in harmony.

The Town of Kerrobert Zoning Bylaw #995-14 provides the setbacks required from your property line to the front, sides and rear of buildings situated on your property. In addition: Section 4.10 of the Zoning Bylaw also allows for "Permitted Yard Encroachments" and states:

- **"4.10.1** Where minimum front, side or rear yards are required in any Zoning District, the following yard encroachments shall be permitted:"
- "a) Uncovered and open balconies, terraces, verandas, decks and patios having a maximum projection from the main wall of 1.8 metres (6 feet) into any required front or rear yard."
- **"b)** Window sills, roof overhangs, eaves, gutters, bay windows, chimneys and similar alterations projecting a distance of 0.6 metres (2 feet) into any required yard."

This means that when calculating where your building can be situated on your lot you measure the required setback distance (as indicated on the lists below) from your property line inward to the front, the side and the rear. The outside wall(s) of your building(s) must be constructed within those setback distances. Any overhangs, eaves or gutters extending beyond the setback distance must not exceed 2 feet.

The following diagram shows how to measure the setbacks.



The following are the regulated setbacks in the Town of Kerrobert for all properties in the Residential 1 (R1) Zoning District as set out in the Zoning Bylaw #995-14.

SINGLE DETACHED DWELLING:

Minimum Lot Area: 465^{m2} (5,005 Ft²)
Minimum Lot Frontage: 15 m (49 Feet)

Minimum Front Yard: 6 metres (20 Feet) from front property line Minimum Rear Yard: 6 metres (20 Feet) from rear property line

Minimum Side Yard: 1.2 metres (4 Feet) from side property line unless your lot is a

corner site then the side yard shall be 2.5 metres (8 Feet) from

side property line

Minimum Floor Area: 75^{m2} (807 Ft²)

MAXIMUM Building Height: 9.0 metres (30 Feet) from grade level to the highest point of roof

(excluding chimneys and antenna)

MAXIMUM Site Coverage: 40% of the total property area, or if you have a corner lot 50%

is allowed

ACCESSORY BUILDING:

Minimum Lot Area: No Requirement Minimum Lot Frontage: No Requirement

Minimum Front Yard: 6.0 metres (20 Feet) from front property line

Minimum Rear Yard: 0.8 metres (3 Feet) unless accessory building has a door or

doors opening onto a lane, then it shall be located not less than 2.0 metres (7 Feet) from the site line abutting the lane.

0.8 metres (3 Feet) Unless side site line is an abutting street

Minimum Side Yard: 0.8 metres (3 Feet) Unless side site line is an abutting street

Then the side yard shall be 3.6 metres (12 Feet)

MAXIMUM Floor Area: 83.6m² (900 Ft²)

MAXIMUM Building Height: 5.5 metres (18 Feet) from Grade level to the highest point of

roof (excluding chimneys and antenna)

PLEASE NOTE: A Development Permit and a Building Permit complete with Plans are required to be

submitted to the Town of Kerrobert *PRIOR* to any site development or construction. Only when the Building Permit has been approved can development commence.

A Development Permit and Building Permit are NOT REQUIRED for for any structure

under 100 Sq.Ft. in size (i.e. 10' x 10').
